What is a sweep?

A sweep is a game in which a person (a player) buys a ticket for a chance to win, by lot, a participant (horse or other contestant) in an approved event.

The prize pool, which comprises the total amount of ticket sales (less expenses and, if applicable, the amount of money raised for the benefiting organisation), is distributed to the players who hold the successful participants in the approved event.

What is a calcutta?

A calcutta follows the same method as a sweep up to the completion of the draw. On completion of the draw, an auction takes place at which all ticket purchasers are entitled to bid for each participant as it is offered.

Players who were successful in the draw may choose between selling the participant and receiving half of the proceeds of the sale, or retaining the participant by making (and paying half of) the highest bid.

The prize pool, which comprises ticket sales and net auction proceeds (less expenses and, if applicable, an amount of money that was raised for the benefiting organisation), is distributed to the ultimate holders of the successful participants in the event.

On what events may a sweep or calcutta be conducted?

A sweep or calcutta may be conducted only on the Melbourne Cup or any other event that is approved. A list of approved events is on pages 7 and 8.

Quick facts

- Permit required if the total value of tickets to be sold is more than \$20,000.
- Can only be conducted in conjunction with an approved event.
- Wages or remuneration cannot be paid unless the sweep or calcutta is authorised under a permit.
- No commission on, or percentage of, or fee for, bets or winnings may be paid.
- No payment or other benefit may be given or sought for the right to enter any place where the sweep or calcutta is conducted.
- Person under 16 are not allowed to play or assist in the conduct of a sweep or calcutta.

If the event is not approved, can I make application for its approval?

Yes. A separate letter of application to have an event approved may be made to the Minister. You must ensure your application includes information that the proposed event satisfies the following policy.

Policy criteria for the prescription of events

- The event and associated sweep and calcutta must have demonstrable wide community support and benefits to the community.
- The event is a recognised sporting event in which there is an element of skill.
- The event is not contrived for the purpose of the conduct of the sweep or calcutta.
- If the event is used to raise funds for a specific body, that body has approved of the event.

Sweeps and calcuttas

- The views of the peak sporting bodies involved with the event are to be obtained, as appropriate.

Policy criteria for the prescription of bush picnic races

- In addition to the above, the following must be satisfied.
- The event may be conducted by an unregistered race club, and must be conducted by an incorporated body.
- The event must be conducted to raise funds for charitable purposes.
- The race is part of a mixed sports meeting where horse and greyhound racing events do not constitute more than 30% of the total number of events or activities.
- No more than six racing events are to be held.
- The mixed sports meeting cannot be advertised or promoted as a race meeting.

Health regulations

The offer of perishable items such as green groceries, meat and fish as prizes is regulated under the *Food Act 2003*.

Such prizes must satisfy the same requirements that apply to food sold through normal retail outlets. These include:

- the manner of handling and packaging the food
- the manner of labelling packages of food
- the temperature at which food must be kept.

Contact NSW Health for more information.

Fish prizes must also comply with the *Fisheries Management Act 1994* and the *Fisheries Act 1935*. A special permit is required.

Contact the Department of Primary Industries for more information.

Who may conduct a sweep or calcutta?

Social sweeps and calcuttas

Anyone may conduct a sweep or calcutta as social entertainment.

Fundraising sweeps and calcuttas

Anyone may conduct a sweep or calcutta for raising funds for a prescribed organisation such as:

- a political party
- a trade union
- a registered club under the *Registered Clubs Act 1976*
- a club registered under the Rules of Racing of the NSW Thoroughbred Racing Board
- a greyhound racing club
- a harness racing club, or
- any organisation not formed or conducted for private gain including charities, social clubs, etc.

You must obtain the written authority of the organisation first if conducted for the benefit of a charity. The promoter or organiser must also comply with the requirements of the *Charitable Fundraising Act 1991*.

Is a permit required?

If total ticket sales will be \$20,000 or less

You may conduct a sweep or calcutta without a permit. However, you must conduct the sweep or calcutta in accordance with the requirements of the *Lotteries and Art Unions Act 1901* and the regulations.

If total ticket sales will be more than \$20,000

A sweep or calcutta cannot be conducted unless you have a permit and conduct it in accordance with the Act, regulations and any conditions imposed on the permit.

How is a permit obtained?

A permit is obtained by completing and lodging the Sweeps/Calcuttas application form which may be obtained by contacting us on 13 32 20 or from our website: fairtrading.nsw.gov.au

The application must be accompanied by a copy of the proposed advertising and a copy of the rules or conditions of entry into the sweep or calcutta.

There are no fees.

What is the prize pool?

The prize pool normally comprises all money invested by players (proceeds of ticket sales and net auction proceeds) less any expenses properly incurred in connection with the conduct of the sweep or calcutta. However, where the sweep or calcutta is conducted for raising funds for a benefiting organisation, an amount may be deducted from the prize pool to be applied to that organisation.

You must advertise to all players how the prize pool is to be divided.

What types of prizes may be offered?

Prizes may consist of or include anything except a prohibited prize. Prizes can be money, goods, wares, merchandise, services, vouchers for goods or services, tickets for admission to any entertainment and tickets (with any spending money) for tours or journeys.

Spending money can be given as part of a tour or journey provided the total value does not exceed 20% of the total value of the travel prize.

Where a money prize exceeds \$2,000, the organiser must pay to the prizewinner the amount as exceeds \$2,000 by means of a crossed cheque payable to the prizewinner, or if the prizewinner so requests, by means

of electronic transfer of funds to an account nominated by the prizewinner.

What types of prizes are prohibited?

The following are prohibited prizes:

- tobacco products,
- firearms or ammunition,
- prohibited weapons,
- cosmetic surgery or other procedure to improve personal appearance
- liquor prizes more than 20 litres.

Tickets for liquor prizes cannot be sold by or to a person under 18. Also a person under 18 cannot give or collect a liquor prize.

What expenses may be deducted?

Expenses properly incurred in connection with the conduct of the sweep or calcutta may be deducted from the total proceeds. These include the cost of purchasing tickets or stationery.

Payment of wages or remuneration

Wages or remuneration cannot be deducted unless the sweep or calcutta is conducted under the authority of a permit.

Payment of commissions

No commission on, or percentage of, or fee for, bets or winnings may be paid.

How much should the benefiting organisation receive?

There is no stipulated amount or percentage that must be provided to a benefiting organisation if the sweep or calcutta is conducted for raising funds for it. However, the organisation should receive a reasonable return. Any advertising or promotion of the game will need to identify the amount or percentage of the total amounts invested to be returned to the benefiting organisation.

Is there a maximum price per ticket?

No. However, the selling price should be consistently applied to all the tickets sold. No ticket should be disposed of except for the advertised value of the ticket or for some other consideration equivalent to the value.

Is there a maximum number of tickets that may be sold?

No.

What is required of the ticket?

Social sweeps and calcuttas

Often, proper tickets would not be normally used where a sweep or calcutta is conducted at a work place, a social gathering, etc. as a social entertainment.

However, where the total value of tickets to be sold will be greater than \$5,000, proper tickets should be produced. These tickets should include the purchase price (its face value) and a serial number. A butt portion should be attached showing a serial number identical to that shown on the ticket proper, and with space for the name, address and telephone number of the purchaser to be written.

Where possible, the ticket should also include the full name and address of the promoter or organiser. A rubber stamp could be used.

Fundraising sweeps and calcuttas

Proper tickets must be produced whenever the sweep or calcutta is conducted for raising funds.

All tickets should be numbered consecutively in the one series. The ticket must include the same serial number as the ticket-butt. Where possible, the ticket should also include its price and the full name of the benefiting organisation. A rubber stamp could be used.

Ticket-butts must be numbered in the same series as the ticket. Ticket-butts should also contain space for the name, address or telephone number of the purchaser to be written.

Social and fundraising sweeps and calcuttas with total ticket sales greater than \$20,000

If the total value of ticket sales will be greater than \$20,000, the ticket must include in addition:

- (if conducted for raising funds) the name and address of the benefiting organisation
- the name, address and telephone number of the promoter or organiser
- the number of tickets to be sold
- the permit number together with the words 'Authorised under the provisions of Section 4D of the *Lotteries and Art Unions Act 1901*'
- the way the prize pool is to be divided
- (if applicable) the amount or percentage of the total amounts invested to be returned to the benefiting organisation
- the ticket must also have a butt portion attached, showing:
 - the same consecutive number as the ticket
 - (if applicable) the name of the benefiting organisation
 - a note that the butt portion must be completed to be eligible to enter the draw.
- how the prize pool is to be divided
- (if applicable) the amount or percentage of the total amounts invested to be returned to the benefiting organisation
- the total amount of estimated expenses to be incurred
- how the winners are to be notified and how to collect prizes
- (for a calcutta) that at the conclusion of the draw, or at some time or place identified, an auction will be held
- (for a calcutta) that successful purchasers must pay for their participants immediately following completion of the auction - no credit can be given
- (for a calcutta) how players are to be told of the outcome of the calcutta.

This information could be printed on the reverse side of the ticket or a separate sheet.

Are there any advertising restrictions?

Yes. You must not publish, or cause to be published, any lottery advertising that:

- encourages a breach of the law, or
- depicts children participating in a lottery activity, or
- is false, misleading or deceptive, or
- suggests that winning will be a definite outcome of entering or participating in the lottery activity, or
- suggests that entering or participating in the lottery activity will definitely improve a person's financial prospects, or
- is not conducted in accordance with decency, dignity and good taste.

In this context, publish includes disseminate in any way, whether by

oral, visual, written or other means (for example, dissemination by means of cinema, video, radio, television or the Internet).

You must not state or imply in any information or publicity that the lottery is authorised or approved by the Government or by any government agency.

Can I charge a fee other than the purchase price of the ticket?

No payment or other benefit is to be given or sought for the right to enter any place where the sweep or calcutta is to be played. However, an entrance fee for admission to a licensed racecourse is acceptable if it is customary and unrelated to the sweep or calcutta.

No payment or other benefit is to be given or sought for the right to participate in a sweep or calcutta (except the investment of stake money).

How should ticket sales be managed?

If you intend to sell tickets in a street or public place in a local government area, you may require written permission from the local council. You should contact your local council for more information.

Are children able to participate in a sweep or calcutta?

No. Persons under 16 are not allowed to play or assist in the conduct of a sweep or calcutta or be present during the draw or the auction.

How should the draw be conducted?

Sellers of tickets must return to the organisers all ticket-butts (or appropriate computer-generated document) relating to tickets sold by

them, the proceeds of sales, and all unsold tickets issued to them before the date fixed for the drawing of the prizes or at any earlier date that the organiser may require.

If a ticket is not included in the draw, the ticket owner should be refunded their money within 7 days after the draw is held.

The draw should be conducted at the place, date and time indicated in any information provided to purchasers. Every ticket holder must be given a fair and equal chance in the draw.

No condition may be imposed that requires a ticket-holder to be present at the drawing.

All sold tickets (or marbles with appropriate numbering) must be placed in a receptacle and drawn at random. The drawn numbers must be matched with a participant (not known to be scratched at the time of the draw) drawn at random from another receptacle. The draw must be conducted in public and, if required, under our supervision.

For a calcutta, the draw and the auction must take place according to the rules of the game, and (if applicable) the details on the application form. If a successful ticket holder is not present, that person's entitlement is according to the rules of the calcutta and must be auctioned in that person's absence.

The drawing device should be large enough to allow all butts or marbles to be included in the draw and to be freely mixed.

An electronic drawing machine may be used, but you must ensure that the program used to draw the numbers is in fact random, and every number entered in the draw has a fair and equal chance of being drawn. If you have doubts about whether your machine satisfies these requirements, you should contact us or the supplier.

How should I notify the results and arrange for the prize to be given to the prizewinner?

This must be according to the rules of the sweep or calcutta.

Where a money prize exceeds \$2,000, the organiser must pay to the prizewinner the amount as exceeds \$2,000 by means of a crossed cheque payable to the prizewinner, or if the prizewinner so requests, by means of electronic transfer of funds to an account nominated by the prizewinner.

What if a prize is unclaimed?

We must be informed of any prize that remains unclaimed at the end of 3 months after the event, together with details of the actions taken to identify or to find the prize winner. You must not dispose of unclaimed prizes until we authorise you to do so.

What records do I need to keep?

Sweeps and calcuttas with total ticket sales over \$5,000

The promoter or organiser of a sweep or calcutta with total ticket sales over \$5,000 must keep records of income and expenditure, including:

- the gross income from ticket sales and, in the case of a calcutta, the gross proceeds from the auction
- the total prize pool
- any deductions as documented by receipts and invoices from gross receipts
- the distribution of any money invested, itemised as to payee, amount and date of payment
- the names and addresses of the persons successful in the draw and, in the case of a calcutta, the names and addresses of all persons who purchased a participant in the calcutta at the auction

- the name and addresses of all prizewinners, together with details of their prizes
- details of all ticket-butts, and the number of unsold tickets together with the serial numbers of those tickets
- if the sweep or calcutta is conducted for raising funds, the total amount given to the benefiting organisation, and details of any receipts from that organisation.

Any record keeping requirement imposed by the *Charitable Fundraising Act 1991* is in addition to those required to be kept by the *Lotteries and Art Unions Act 1901*.

If tickets are to be sold over several days or weeks, money received is to be placed into an account at a bank, building society or credit union (being an account belonging to the benefiting organisation) as soon as practicable, preferably within two business days. All payments should be made from this account.

Sweeps and calcuttas with total ticket sales of \$5,000 or less

The Act does not require you to keep records if the total ticket sales in a sweep or calcutta will be less than \$5,000. However, it is recommended that you keep these records as far as is practicable. This will assist you to manage the sweep or calcutta properly.

How long are records required to be kept?

The promoter or organiser must retain all records in relation to the sweep or calcutta for at least 3 months. However, if the sweep or calcutta is conducted for raising funds for a benefiting organisation, the records must be kept by that organisation for 7 years.

Any unsold tickets must be retained for at least 3 years (or such shorter

period as approved by us) after the date of the draw. This requirement does not apply if the value of the tickets sold is less than \$5,000.

Are financial statements or returns required?

A return is not required to be lodged with us unless specifically requested. However, you must tell us immediately if any discrepancy is found between the amount of gross receipts as determined by the ticket sales or the auction and the amount of gross receipts as determined by totalling the cash receipts.

Who is responsible?

The promoters or organisers are jointly and individually responsible for the proper management and conduct of the sweep or calcutta.

Fundraising sweeps and calcuttas

A subcommittee may be elected from within the benefiting organisation to be the organising committee. Alternatively, the benefiting organisation may authorise persons outside the organisation to conduct the sweep or calcutta on its behalf. The management committee of the benefiting organisation should satisfy itself as to the good standing and competence of the persons organising the sweep or calcutta.

The benefiting organisation should introduce adequate controls to supervise the organisers, including:

- insisting on reports
- ratifying all expenses and prizes awarded
- having full access to records and registers
- ensuring financial records are audited.

Are the records subject to inspection?

Yes. All records are subject to inspection by our authorised officers and police.

Are there any penalties?

Yes. There is a range of penalties for conducting a sweep or calcutta contrary to requirements, including:

- failing to award the winner the prize
- conducting a sweep or calcutta fraudulently
- misappropriating funds or prizes
- making false statements
- failing to keep books and records
- awarding prohibited prizes
- unlawful advertising
- hindering or obstructing authorised officers or police
